WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 SHRI BANKEY BIHARI SHIKSHA PRASAR SAMITIRUN BY SHRI BANKEY BIHARI SHIKSHA PRASAR SAMITI) NEAR DAK BUNGALOW, ATER ROAD, BEHIND-477001, MADHYA PRADESH has submitted an application (Code No- AFW07655/222003(AoD.) to the Western Regional Committee of NCTE for grant of recognition/permission for permission for Additional intake in existing DED(CO-ED) course with an annual intake of 50 students in 10-2008.

AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the report received from the visiting team in the form of report and Adequacy, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the FLE teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Western Regional Committee hereby grants permission to 1993 SHRI BANKEY BIHARI SHIKSHA PRASAR SAMITIRUN BY SHRI BANKEY BIHARI SHIKSHA PRASAR SAMITI) NEAR DAK BUNGALOW, ATER ROAD, BEHIND-477001, MADHYA PRADESH for Additional intake of 50 students in the existing DED(CO-ED) course from academic session 2009-2010 of ELE of 2 year duration with an annual intake of 50 ELE under clause 1(1) of NCTE Recognition Norms & Procedure) Regulation 2007 with this the total approved intake for the DED(CO-ED) course to the institution SHRI BANKEY BIHARI SHIKSHA PRASAR SAMITI becomes 100.

The institution shall within the limits of the scope of recognition order, convert the endowment fund and reserve fund accounts into a separate bank account with the sanction of the Western Regional Committee.

The institution shall comply with the various other norms and standards prescribed in the NCTE regulations as amended from time to time.

The institution shall make admission only when it obtains sanction from the examining body in terms of clause 8(2) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.
